Government Edward College, Pabna, is proud to announce the launch of its official academic and research journal, the **Edward Review**. We invite academics, researchers, and students to submit original, high-quality, and **value-free research** for its inaugural issue, slated for **2025**.

The Edward Review is a **multidisciplinary journal** dedicated to fostering rigorous research and academic discourse. We embrace **methodological pluralism** and welcome a variety of submission types, including News and Views, Commentary, Surveys, Methodological and Ideological Options, Analysis, Book Reviews, and Letter to the Editor.

We encourage submissions across a broad spectrum of disciplines, covering, but not limited to Humanities & Social Sciences, Business & Commerce, Natural & Physical Sciences, Economics & Development Studies, Education, Language & Literature, History & Culture, Environment & Sustainability, Technology, ICT and Innovation.

All submitted manuscripts will undergo a rigorous **double-blinded peer-review process**, followed by a review from the editorial board. We employ strict checks to prevent plagiarism and the submission of Algenerated content.

The manuscript must be typed and use the following formatting- Referencing Style: APA (7<sup>th</sup> Edition), Abstract: 150-250 words, Keywords: 4-6, Language: English (USA) or Bangla, Font: Times New Roman, Size 12, Line Spacing: 1.5, Paper Size: A4, Margins: 1 inch (2.54 cm) on all sides, and Color: All content, including text, shading, and graphs, must be monochromic (black and white). Interested researchers are requested to submit manuscript in both Microsoft Word (.doc/.docx) and PDF formats via email toedwardcollegejournal@gmail.comON or BEFORE 30 September 2025.

Each submission must include a **separate**, **signed cover letter** with the following information for all authors:full name(s), contact details (telephone number and email), institutional affiliation, ORCID ID (if available), a declaration stating that the submitted manuscript has not been published or submitted for publication in other journal, and short bio (maximum 100 words)

By contributing to the Edward Review, you will be part of the first academic and research journal in the proud history of Government Edward College, gaining recognition within national and international academic and research circles.

#### About the Journal

#### Aims and scope

The Edward Review is a multidisciplinary academic and research journal, aiming to foster rigorous research and academic discourse across a broad spectrum of disciplines. Its scope encompasses, but is not limited to, Humanities & Social Sciences, Business & Commerce, Natural & Physical Sciences, Economics & Development Studies, Education, Language & Literature, History & Culture, Environment & Sustainability, Technology, ICT and Innovation. The journal embraces methodological pluralism and welcomes various submission types.

All submissions to Edward Review are reviewed using the general criteria of quality, creativity, originality, accuracy, and contribution to our proposed field. There are several categories of articles to allow for a full range of constructive dialogue.

# Article Types

Manuscripts should fall into one of seven categories: News and Views, Commentary, Surveys, Methodological and Ideological Options, Analysis, Book Review, Letter to the Editor.

**News and Views** are intended to be topical and timely short pieces reviewed by the editor and/or one outside reviewer at the editor's discretion. These may include editorials, letters to the editor, news items, and policy discussions. Letters to the Editor should not contain references to personalities, but rather focus on ideas. Maximum 1500 words (600 words for letters).

Commentaries are essays discussing critical issues. They are reviewed by two outside reviewers with the criteria weighted toward quality of the exposition and importance of the issue. 5000 words or 12 double-spaced pages.

**Surveys** examine and review important general subject areas. They are reviewed by two outside reviewers with the criteria weighted toward importance of the subject and clarity of exposition. 8000 words or 25 double-spaced pages.

Manuscripts devoted to **Methodological and Ideological Options** develop new methodologies or investigate the implications of various ideological assumptions. They are reviewed by two outside reviewers with criteria weighted toward originality and potential usefulness of the methodology or ideological option. These should not exceed 8000 words or 25 double-spaced pages.

Research articles devoted to **Analysis** of important questions in the field are reviewed by two outside reviewers with the criteria weighted toward originality, quality, accuracy of the analysis, and importance of the question. Maximum 8000 words or 25 double-spaced pages.

**Reviews of Recent Books** are reviewed by one outside reviewer with criteria weighted toward clarity and accuracy of the review and importance of the book to the field. The maximum length for book reviews is 1200 words or 4 double-spaced pages.

Letters to the Editor should be less than 2 pages of 600 words.

#### **Peer Review**

This journal follows a single anonymized review process. Your submission will initially be assessed by our editors to determine suitability for publication in this journal. If your submission is deemed suitable, it will typically be sent to a minimum of two reviewers for an independent expert assessment of the scientific quality. The decision as to whether your article is accepted or rejected will be taken by our editors.

Our editors are not involved in making decisions about papers which:

- they have written themselves.
- have been written by family members or colleagues.
- relate to products or services in which they have an interest.

Any such submissions will be subject to the journal's usual procedures and peer review will be handled independently of the editor involved and their research group.

### **Declaration of Generative AI in Scientific Writing**

Authors must declare the use of generative AI in scientific writing upon submission of the paper. The following guidance refers only to the writing process, and not to the use of AI tools to analyze and draw insights from data as part of the research process:

- Generative AI and AI-assisted technologies should only be used in the writing process to improve the readability and language of the manuscript.
- The technology must be applied with human oversight and control and authors should carefully
  review and edit the result, as AI can generate authoritative-sounding output that can be incorrect,
  incomplete or biased. Authors are ultimately responsible and accountable for the contents of the
  work
- Authors must not list or cite AI and AI-assisted technologies as an author or co-author on the
  manuscript since authorship implies responsibilities and tasks that can only be attributed to and
  performed by humans.

The use of generative AI and AI-assisted technologies in scientific writing must be declared by adding a statement at the end of the manuscript when the paper is first submitted. The statement will appear in the published work and should be placed in a new section before the references list. An example:

- Title of new section: Declaration of generative AI and AI-assisted technologies in the writing process.
- Statement: During the preparation of this work the author(s) used [NAME TOOL/ SERVICE] in
  order to [REASON]. After using this tool/service, the author(s) reviewed and edited the content as
  needed and take(s) full responsibility for the content of the published article.

The declaration does not apply to the use of basic tools, such as tools used to check grammar, spelling and references. If you have nothing to disclose, you do not need to add a statement. Writing and Formatting File format

We ask you to provide editable source files for your entire submission (including figures, tables and text graphics). Some guidelines:

- Save files in an editable format, using the extension .doc/.docx for Word files and .tex for LaTeX files
- Lay out text in a single-column format.
- Remove any strikethrough and underlined text from your manuscript, unless it has scientific significance related to your article.
- Use spell-check and grammar-check functions to avoid errors.

#### Title page

You are required to include the following details in the title page information:

- Article title. Article titles should be concise and informative. Please avoid abbreviations and formulae, where possible, unless they are established and widely understood, e.g., DNA).
- Author names. Provide the given name(s) and family name(s) of each author. Carefully check that all names are accurately spelled.
- Affiliations. Add affiliation addresses, referring to where the work was carried out, below the author
  names. Indicate affiliations using a lower-case superscript letter immediately after the author's
  name and in front of the corresponding address. Ensure that you provide the full postal address of
  each affiliation, including ORCID ID and, if available, the email address of each author.

Corresponding author. Clearly indicate who will handle correspondence for your article at all stages
of the refereeing and publication process and also post-publication. This responsibility includes
answering any future queries about your results, data, methodology and materials. It is important
that the email address and contact details of your corresponding author are kept up to date during
the submission and publication process.

#### Abstract

You are required to provide a concise and factual abstract which does not exceed 250 words. The abstract should briefly state the purpose of your research, principal results and major conclusions. Some guidelines:

- Abstracts must be able to stand alone as abstracts are often presented separately from the article.
- Avoid references. If any are essential to include, ensure that you cite the author(s) and year(s).
- Avoid non-standard or uncommon abbreviations. If any are essential to include, ensure they are
  defined within your abstract at first mention.

#### Keywords

You are required to provide 4-6 keywords for indexing purposes. Keywords should be written in English. Please try to avoid keywords consisting of multiple words (using "and" or "of"). We recommend that you only use abbreviations in keywords if they are firmly established in the field.

### Math formula

- Submit math equations as editable text, not as images.
- Present simple formulae in line with normal text, where possible.
- Use the solidus (/) instead of a horizontal line for small fractional terms such as X/Y.
- · Present variables in italics.
- · Denote powers of e by exp.
- Display equations separately from your text, numbering them consecutively in the order they are referred to within your text.

#### **Tables**

Tables must be submitted as editable text, not as images. Some guidelines:

- Place tables next to the relevant text or on a separate page(s) at the end of your article.
- Cite all tables in the manuscript text.
- Number tables consecutively according to their appearance in the text.
- Please provide captions along with the tables.
- Place any table notes below the table body.
- Avoid vertical rules and shading within table cells.

We recommend that you use tables sparingly, ensuring that any data presented in tables is not duplicating results described elsewhere in the article.

#### Figures and images

- Cite all images in the manuscript text.
- Number figure/images according to the sequence they appear within your article (for example, Figure 1, Figure 2 etc).
- Please provide captions for all figures, and images. A caption should consist of a brief title and a
  description of the figure/ image. We advise you to keep the amount of text in any image to a
  minimum, though any symbols and abbreviations used should be explained

# **Article Structure**

Article sections

- Divide your article into clearly defined and numbered sections. Number subsections 1.1 (then 1.1.1, 1.1.2, ...), then 1.2, etc.
- Use the numbering format when cross-referencing within your article. Do not just refer to "the text."
- You may give subsections a brief heading. Headings should appear on a separate line.
- Do not include the article abstract within section numbering.

# Author Contributions: CRediT

Corresponding authors are required to acknowledge co-author contributions using CRediT roles: Conceptualization, Data curation, Formal analysis, Funding acquisition, Investigation, Methodology, Project administration, Resources, Software, Supervision, Validation, Visualization, Writing – original draft, and Writing – review and editing.

# Reference Style APA 7th Edition

All citations in the text should refer to:

- Single author: the author's name (without initials, unless there is ambiguity) and the year of publication.
- Two authors: both authors' names and the year of publication.
- Three or more authors: first author's name followed by 'et al.,' and the year of publication.

Citations can be made directly (or parenthetically). Groups of references can be listed either first alphabetically, then chronologically, or vice versa. Examples: "as demonstrated (Allan, 2020a, 2020b; Allan & Jones, 2019)" or "as demonstrated (Jones, 2019; Allan, 2020). Kramer et al. (2023) have recently shown.

The list of references should be arranged alphabetically and then chronologically if necessary. More than one reference from the same author(s) in the same year must be identified by the letters 'a', 'b', 'c', etc., placed after the year of publication.
